The bidder, whether acting as principal, agent, officer or director of a company or otherwise, in any capacity whatsoever shall indemnify and hold harmless the auctioneer from any and all actions, cause of action, suits, damages, costs and losses of any nature arising from attending or participation of the bidder at this auction sale.
3. The bidder agrees to be responsible for the complete payment of the purchase price, applicable taxes and buyer's fees that accompany this auction.
4. The bidder shall be bound by the auctioneer's terms of payment conditions.
5. The bidder acknowledges that the auction site has the potential hazards and risks and they must be aware at all times. The auction sale yard has moving vehicles, flammable and corrosive materials, pressurized tanks, heavy machinery, and damaged vehicles that may have sharp metals exposed and broken glass.
